## **Proceedings:**

- 1. Call to order and Board Member quorum established 4 of 7 members present.
- 2. Minutes: The minutes of the January 22, 2020, Annual Meeting were approved via email and posted to the website; **VOTE 6** YES; **0** NO.

#### 3. Nominations for Officers:

# 4. Financial Report/Vista Management:

Reconciliation Report: **Balance** as of December 31, 2019 - \$73,863.82

Current delinquencies: \$28,048.69

The Board agreed to waive late fees for 2020 if delinquent accounts are paid in full by October 1, 2020. It was also agreed to waive fines until October. Jenny will draft a letter to delinquent homeowners offering a 6 month payment plan with waiver of late fees to be mailed by May 22, 2020.

**5. Audit Report:** Audits for the years 2018 and 2019 were completed by Joseph Vandal, CPA, PS. In his report, Mr. Vandal stated that "In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Crystal Ridge Homeowners' Association of Puyallup. . . . and the results of its operations and its cash flows for year then ended in conformity with accounting principles generally accepted in the United States of America."

# 6. Landscape report:

50 trees have been replanted. A variety of trees were approved by the City for planting. Included in the list of approved trees are red maples, vine maples, and small ornamental evergreens. The new "street rules" from the City require 25% - 50% of new trees must be evergreen.

Olympic Landscaping will begin weed and moss control and hard edging. Jenny will drive through on Monday listing essential maintenance. Jenny will also clarify Olympic's plan for social distancing among employees.
