Neighborhood Annual Meeting

Our annual neighborhood meeting will be held at Nelson Crane Elementary School on Thursday, January 17, 2002 at 7 pm. All residents are welcome to attend.

2002 Board of Directors Elections - Two positions are open on the Board of Directors. One person from the Estates and one person from the Classics or Janelle Estates needs to be elected to fill these two positions.

Want to Serve on the Board? - If you would like to run for election to the Board, please contact us via email or letter so we can add your name to the ballot. Homeowners in good standing (dues are current) from the Estates, the Classics and Janelle Estates who would like to serve a three-year term on the Board of Directors are eligible to run for election. All nominations will be taken from the floor at the Annual Meeting.

Voting - To vote in this election, you be must be present at the Annual Meeting. If you cannot attend the meeting, you can designate a proxy to vote on your behalf. To vote, both you and your proxy must be current on all dues. The proxy form is on the bottom of page 4 of this newsletter for your use. Just cut out the form, fill it out completely and have your designated proxy bring it to the Annual Meeting to vote on your behalf. Do not mail the proxy form to us.

HOA Dues - Thank you to everyone who has paid their dues already. We sincerely appreciate your prompt payment. Please remember that all amounts owed are due by January 31, 2002. This year the Board will be working diligently to collect all current and past dues owed. Your timely payment of your dues owed will prevent you from incurring additional costs such as late fees, property liens, or legal fees from turning delinquent accounts over to an attorney for collection.

2001 & 2002 Budgets - On pages 2 and 3 of this newsletter, you'll find a copy of our 2001 Budget and Year-To-Date Expenditures and of our Year 2002 Proposed Budget. Please take some time to review these budgets. We will be discussing these budgets at our annual meeting.

Leash & Scooper Laws - The City of Puyallup has leash and scoop laws requiring pets to be on a leash and picked up after. The fines can be as high as \$475 per offense for allowing your dog to run loose and for not picking up after your dog. Animal Control suggests that you contact them at 841-5595 if you see an animal loose or if you can catch it on film. This continues to be a frequent complaint from our residents. Please be a responsible pet owner and keep your dog on a leash, don't let your dog run loose, and please scoop up after your dog. Thank you for your help.
