## **Board Elections**

One Position Open - In January 2003, one position will be open on the Board of Directors to be filled by someone from the Estates. Homeowners in good standing from the Estates who would like to serve a three-year term on the Board of Directors are eligible to run for election. Our election procedures are explained on our web site at http:// crystalridge.amajn.com. If you don't have access to the web, please send us a letter requesting a copy of the procedures.

Want to run for election? - If you are interested in filling this position on the Board, please contact us via email or letter. To introduce yourself to the neighborhood, you can submit one or two short paragraphs about yourself to be included in the January 2003 newsletter which will be mailed before our Annual Meeting scheduled for January 16, 2003. If you plan to run and would like to have your paragraphs in the newsletter, please notify us of your intent to run and your write-up by December 20, 2002.

### **2003 Dues**

HOA dues notices for 2003 with a dues increase will be mailed in December, 2002.

#### **Dues Increase**

The Board has voted to raise HOA dues assessments by 10% for 2003 per the CCRs, Article VIII, Section 3(b). Annual assessments will increase for the Estates from \$360/year to \$396/year and for the Classics and Janelle Estates from \$240/year to \$264/year. This is the first dues increase for Crystal Ridge HOA since its inception in 1992 and is justified now to cover rising costs and help build our reserve account to provide funds for future modifications and/or major repairs in the neighborhood. Though not a guarantee, this reserve account may help avoid the need for a special assessment in the future. The Board is also considering hiring a property management firm to assist the HOA. Why? Some reasons identified are:

- To provide long term stability for the Board of Directors as its individual members rotate
- To provide consistent liaison between the Board, homeowners, renters, contractors and the city of Puyallup
- To reduce work loads on the current Board members
- To assist in the enforcement of the CCRs
- To provide assistance with managing landscape contractors and our landscape requirements
- To provide a central filing area for important HOA documents
- To provide legal services to the HOA
- To assist in the management of the Board email and the neighborhood web site

### **Outstanding Dues & Late Fees**

The Board has been working diligently to collect all outstanding dues and late fees and, as a result, our outstanding balances have decreased. Liens have been filed on delinquent accounts and liens have been cleared on accounts brought current. Our effort will continue to reduce our backlog of overdue accounts. We will file liens in 2003 on any property with a outstanding dues and/or late fee balance from 2002 and prior.

## HOA Reminders

<u>LANDSCAPING CONTRACT</u> - The landscaping committee has been working this fall to obtain new competitive bids for our landscaping contract. If you are interested in being a part of this committee, please contact the Board.

<u>CAR THEFTS</u> - Crystal Ridge has recently experienced car thefts in the neighborhood. Because our street lights do not cover all areas, improved neighborhood security and a possible reduction in car theft could be achieved if all residents turned their outside lights on at night. Please consider this simple step to help improve security in Crystal Ridge.

<u>ICE & SNOW</u> - No big surprise here! Winter brings reduced day light hours, ice, snow, and strong winds. Please remember to be careful on the icy streets, sidewalks and driveways during this winter season. Please park your cars off the street when we have ice or snow storms to help in the ice and snow removal effort by the City of Puyallup.

MODIFICATION REQUESTS - Residents are required by the CCRs to submit a "Modification Request Form" for approval by the Board of Directors <u>before</u> you do any exterior modifications to your property. This includes home painting, structural additions, fences, sheds, pools, etc. Review your copy of the CCRs (also available online) for the requirements. Contact the Board via email or letter if you have questions. Please allow 15 days for review of your modification request. "Modification Request Forms" can be obtained from our web site or you can write the Board and ask that one be sent to you.

MAIL & IDENTITY THEFT - Mail and identity theft is a frequent item in the news these days. Some Crystal Ridge residents have been victimized. Mail left in unsecured mail boxes potentially allows thieves to steal your credit cards, pin numbers, ID cards, checks, cash, and your identity. It is a crime, intrusive on your personal lives, and can be a major headache to clear up. There are some steps you can do to help protect yourself:

- Open a PO Box
- Install locking mailboxes
- Never leave mail in your mailbox overnight
- Remove mail as soon as it is delivered
- Drop outgoing mail off at the post office
- Notify the post office to hold your mail when absent
- Stay alert
- Report suspicious activity to the police

If you and your neighbors decide to convert to secure mailboxes, as others have done already, the procedures for approval are on our web site (http://crystalridge.amajn.com). If you don't have access to the web, contact the Board and we will send you a copy of the procedures. See our address at the bottom of page 1 of this newsletter.

**25 MPH Speed Limit** - All residents are reminded that the speed limit in Crystal Ridge is 25 MPH. Please slow down and keep our neighborhood safe.
